CORE Infographic Initiative: Translating Research into Information for Patients

Veterans and patients should have access to findings from research about their health, especially when that research may affect their healthcare and self-care decisions. To address this need, the Pain/Opioid CORE created the infographic initiative to develop a series of infographics to communicate research results to patients and their caregivers.

Pain/Opioid CORE Staff, Veteran Engagement Panel members, study authors, and experienced health communication and data visualization professions have co-created infographics for dissemination to Veterans and patients. Pain/Opioid CORE Veteran Engagement Panel Updates

The Pain/Opioid CORE Veteran Engagement Panel (VEP) consists of thirteen Veterans with personal experience with chronic pain, opioid use, or opioid use disorder. This panel was established to connect Veterans with the VA pain/opioid research community, facilitate Veteran-engaged research, and promote two-way learning.

Recently, CORE staff and two VEP members co-presented a Veteran Engagement Forum at the 2023 HSR&D/QUERI National Meeting. During the interactive presentation, titled *Engagement is at our CORE: Sharing the Successful Model of the Pain/Opioid CORE Veteran Engagement Initiative*, they highlighted recent VEP work and discussed:

- How this national, standing VEP is contributing to pain/opioid research and how its operational model can be applied in other settings;
- How trained engagement staff, Veteran panel members, and guest researchers come together in a successful engagement triad; and
- Best practices for preparing Veterans and researchers for fruitful meetings and evaluation methods to ensure continuous improvement of the engagement experience to deliver constructive outcomes.

The HSR&D meeting and various Veteran Engagement forums and posters provided a positive opportunity for Veteran Engagement groups to share with and learn from one another.

Pain/Opioid CORE Career Development Researcher Spotlight

Spotlighting a researcher or research team who actively participate in Pain/Opioid CORE Career Development activities is a new feature of the CORE newsletter. This issue spotlights researchers, Drs. Ashely Griffin and Sarah Javier, from the VA Palo Alto Center for Innovation to Implementation (Ci2i) and Stanford University School of Medicine.

Ashley Griffin, a Medical Informatics fellow the VA, is currently developing an HSR&D Career Development Award that focuses on leveraging patient-generated health data to improve shared decision-making for Veterans with chronic pain. Her research centers around informatics, interoperability, and pain.

Sarah Javier is a Research Health Science Specialist at her VA and a recent recipient of the HSR&D Career Development Award. Her research focuses on developing a tailored implementation blueprint to enhance Veterans of color and women Veterans' engagement with non-pharmacological pain treatments; and lies at the intersection of health equity, implementation science, and chronic pain.

Ashley and Sarah are 2022 Pain/Opioid CORE Rapid Start Funding awardees and are together investigating *Proactive Messaging to Facilitate Veteran Engagement in Non-Pharmacological Pain Treatments*. To best serve the Veteran population with this research, they have met with three different Veteran Engagement panels – including the CORE's panel – to create Veteran-centered materials for their study.

New Website Resource for Researchers: Mapping Review

Last year, Pain/Opioid CORE leaders and VA program partners convened for initial discussions about updating the CORE's research priorities. To assist in this process, CORE staff conducted a mapping review to summarize and categorize the existing literature across 16 condition categories and 19 treatment strategy categories. Results from searches for relevant systematic reviews in PubMed and Cochrane Review databases were triaged, categorized, and documented in the *Evidence Landscape Tables*. You can also access the companion *Article List* document which lists the citation and hyperlink to each numbered publication in the *Evidence Landscape Tables*.
